Please be advised that the City of Los Angeles Solid Waste Local Enforcement Agency (LEA) received and approved a Report of Facility Information (RFI) amendment to the Solid Waste Facility Permit for the Active Recycling & Transfer Station. The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within the City of Los Angeles, including all transfer stations.

Description of Project and LEA's Determination

The Active Recycling facility is a 3.56-acre transfer station located at 2000 W. Slauson Avenue in Los Angeles, California.

On March 16, 2023, the LEA received from Active Recycling an application for a modification to the SWFP to exchange metal recycling for curbside recycling material.

The LEA finds that the proposed change is consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA approved the modification and CEQA addendum on April 11, 2023.
