Transmittal of Registration Permit

Dear Ms. Bazon,

On July 29, 2023, the Local Enforcement Agency (LEA) received a Registration Permit Application package from Express Disposal, Inc., for the Express Disposal, Inc., to operate a Medium Volume Chipping and Grinding Facility as set forth in section 18104, Title 14 of the California Code of Regulations. The facility is located at 2221 Washington Boulevard, Los Angeles, CA 90021. The LEA has completed the review of the Registration Permit Application package and has made the following findings:


- (1) The application package identifies Express Disposal, Inc., as the operator and 2221-2235 Washington LLC as the facility owner and contains the address and phone numbers for themselves.
- (2) The application contains the correct sections in Chapter 3 of Division 7 of this Title authorizing eligibility for this tier. The application package describes the facility's operations and how it will comply with applicable state regulations. The facility will have a site capacity of 700 tons, with a peak loading of 500 tons per day, and an annual loading of 36,000 tons of green waste and wood. The facility will be open from 5:00 am to 10:00 pm, 7 days per week.
- (3) The application package contains a statement by the owner / operator certifying under penalty of perjury that the information which they have provided is true and accurate and that they will comply with the conditions of the permit, federal, state, and local enactments.

(4) In accordance with 14 CCR, section 18104.2, the LEA has made the following determination. The application package meets the requirements of 14 CCR, section 18104.1.

Therefore, the LEA is issuing the enclosed Registration Permit to Express Disposal, Inc., to operate as a Medium Volume Transfer Processing Facility. This letter shall serve as notification to CalRecycle of the issuance of the Registration Permit.
