Description of Project and LEA's Determination

The CWS-DTLA facility is a 1.24-acre transfer station located at 3720 Noakes St., in Los Angeles, California.

On June 14, 2023, the LEA received from CWS-DTLA an application for a modification to the SWFP to shift the permitted boundary and make changes to the location of the loading area for the sorting machine and bunkers.

The LEA finds that the proposed change is consistent with all applicable certified and/or adopted CEQA documents including the Addendum of April 2023, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA approved the modification and CEQA addendum on June 20, 2023.
