Transmittal of Registration Permit

Dear Mr. Medrano,

On January 2, 2024, the City of Los Angeles Local Enforcement Agency (LEA) received an application package from North Hills Recycling Inc. for a medium volume chipping and grinding facility located at 11700 Blucher Avenue in Granada Hills (Los Angeles), California. The LEA has reviewed the application package and has made the following findings:

1. The application package identifies North Hills Recycling as the facility operator and contains the contact person, address, and phone number. The application package identifies Henry & Louse Arklin TRS as the owner of the property and contains the appropriate contact information.
2. The application contains the correct section in Chapter 3 or 3.1 of Division 7 of this Title authorizing eligibility for this tier. The application package describes the facility's operations and how it will comply with applicable state regulations. The facility will have a maximum capacity of 499 tons per day of chipping and grinding material with an annual loading of 168,662 tons. The facility will be opened from Monday to Saturday at 6:00am-6:00pm and Sunday at 6:00am – 2:00pm.

3. A copy of the application was transmitted to the Director of the City Planning Department.
4. No public hearings were required for the permitting of this facility.
5. The application package contains a statement by the owner and operator certifying under penalty or perjury that the information which they have provided is true and accurate to the best of their knowledge and belief.


In accordance with 14 CCR 18104.2, the LEA has made the following determination. The application package meets the requirements of 14 CCR 18104.1. Therefore, the LEA is issuing the enclosed Registration Permit to North Hills Recycling to operate a medium volume chipping and grinding facility. This letter shall serve as notification to CalRecycle of the issuance of the Registration Permit.

Pursuant to 14 CCR 18103.3 each operator of an EA Notification operation is required to notify the enforcement agency in writing 15 days prior to the cessation of operations.

Note that the acceptance of this application does not relieve the owner or operator from complying with all other local, state, and federal requirements. The LEA encourages you to contact local departments to ensure you are in compliance with their regulations.
