Dear Mr. Taisopoulos:

On September 23, 2023, the City of Los Angeles Local Enforcement Agency (LEA) received an application package from Sun Valley Paper Stock for an RFI Amendment for the Sun Valley Paper Stock MRF & Transfer Station. The RFI amendment was submitted to modify the TPR to update the report addition of Senate Bill 1383 requirements, new scale and scale house, and relocation of piles throughout the property.

In accordance with Title 27, Section 21650(a) of the California Code of Regulations, the LEA has made the following determinations. The application package meets the requirements of Title 27, Section 21570, and is acceptable for filing, and the Report of Station Information meets the requirements of Title14, Section 18221.

No change to the SWFP is necessary so an RFI amendment is the appropriate level of documentation for this facility.

In accordance with Title 27, Section 21665(c) of the California Code of Regulations, the LEA has made the following determinations.

- 1. The proposed change does not have the potential to cause a significant effect on the environment and pursuant to Title 14, Section 15061 (b)(3) of the California Code of Regulations, is exempt from CEQA.
- 2. The proposed change is acceptable and consistent with state minimum standards.

3. The proposed change does not conflict with the terms and conditions in the current solid waste facility permit (SWFP).

The LEA is transmitting a copy of the RFI amendment, and a copy of the permit application for your files. Pursuant to 27 CCR 21660.1, the LEA has posted a copy of the public notification on the LEA bulletin board and the City Hall bulletin board. The operator has posted a copy of the notification at the Sun Valley Paper Stock MRF & Transfer Station. These public notices will be posted for a period of 10 days.
