EARLY NOTICE REGARDING DISCRETIONARY REVIEW

Many construction or remodeling projects are often subject to discretionary approvals prior to the issuance of the necessary building permit. Discretionary approvals may require a public hearing and may be subject to appeals. Building permits cannot be issued until the discretionary process has taken place and any appeal period has concluded and/or any appeals have been settled.

Please review the Parcel Profile Report/Building Permit Application for your property. If any of the following designations appear on the report, be advised that an additional discretionary review may be required for your proposed project. You are advised to initiate the review process as soon as possible as discretionary review for some of these designations may require significant processing time.

Inquiries regarding any additional review should be directed to the appropriate agency. Contact information for each designation is shown below. Additional information concerning the necessary review process may also be available at the agencies' websites.

- Mini-Mall (Mini Shopping Center)
- Commercial Corner Development
- Penny Arcade
- Recycling Centers
- Storage Buildings for Household Goods.
