# ZONING AND LAND USE REQUIREMENTS

## Notice to All Business Tax Registrants

The City of Los Angeles Municipal Code requires compliance with all zoning and land use requirements for business activities conducted within the City of Los Angeles. Before beginning a new business (or if you are concerned about the legality of an existing business) you are advised to contact your local Building and Safety Office to verify that the business complies with City zoning and occupancy requirements.
