LEA Transmittal of Proposed SWFP

Dear Mr. Escotto:

On March 16, 2023, the City of Los Angeles Local Enforcement Agency (LEA) received an application package for a modified solid waste facility permit (SWFP) from Active Recycling. The operator proposed to change metal recycling to curbside recycling. The LEA reviewed the application package according to the solid waste facility permit requirements found in Title 14 of the California Code of Regulations. On April 11, 2023, the LEA made the determination that the application package is complete and correct and ready for filing.

An Environmental Impact Report (EIR) Addendum was produced to support the application package for the modification of the existing SWFP to allow the permitted daily tonnage of metal recyclables to be replaced with curbside recyclables. The EIR addendum analysis demonstrates that there would be no any significant impact by the change in material.

Pursuant to 27 CCR 21650(g), the LEA is transmitting the following information to CalRecycle:

- A copy of the proposed permit;
- A copy of the accepted application package;
- The LEA has determined the application package is complete and correct and that the Transfer Processing Report meets the requirements of 14 CCR Section 18221.6;
- The LEA finds that proposed permit is consistent with and is supported by CEQA analysis and EIR Addendum (State Clearinghouse: 2007031090);
- A copy of the last 5-year permit review report, dated September 23, 2019.
