On May 28, 2024, the City of Los Angeles Local Enforcement Agency (LEA) received an application package from Arakelian Enterprises, Inc. dba Crown Recycling Services for a modification of the solid waste facility permit for the Crown Recycling Services large volume transfer/processing facility that is located in Los Angeles, CA. The application was for the consolidation of the different categories of municipal solid waste in their permit within the enclosed building. The LEA reviewed the application package according to the solid waste facility permit requirements found in Title 14 and Title 27 of the California Code of Regulations and on June 27, 2024, the LEA made the determination that the application package is complete and correct and is ready for filing.

This permit application package contains the following items:

- 1. A completed application (CIWMB form E-1-77).**
The LEA has reviewed the application and has determined that the operator has properly completed the form. The application package contains a statement from Mr. David Oeffling, Director of Environmental Compliance at Crown Recycling Services certifying that the application is true and accurate to the best of his knowledge.
- 2. A complete and correct Transfer/Processing Report (TPR).**
The LEA has reviewed the Crown Recycling Services Report and has determined that it is in compliance with the requirements found in 14 CCR 18221.6.
