Completeness Determination for Solid Waste Facility Permit Application Package

Dear Ms. Markie,

On March 7, 2016, the City of Los Angeles Local Enforcement Agency (LEA) received an application from California Waste Services (CWS) to revise the solid waste facility permit application package that was being processed to allow for a consolidation of the Large Volume Construction and Demolition/Inert (CDI) Debris Processing Facility and the Type A Inert Operation into a single permit.

LEA reviewed the application package according to the solid waste facility permit requirements found in Title 14 and Title 27 of the California Code of Regulations and on April 6, 2016, the LEA made the determination that the application package is complete and correct and ready for filing.

This permit application package contains the following items:

1. A completed application (CIWMB form E-1-77).
The LEA has reviewed the application and has determined that the operator has properly completed the form. The application package contains a statement from Mr. Eric Casper, Owner of CWS, certifying that the application is true and accurate to the best of his knowledge.
2. A complete and correct Facility Report.
The LEA has reviewed the California Waste Services Facility Report and has determined that it is in compliance with the requirements found in 14 CCR 18223.5.

3. CEQA

A Mitigated Negative Declaration (MND) was previously certified in November 2008 for the design and operational changes originally proposed for the mechanized recyclable material separation process. In September 2011 the Lead Agency prepared an Addendum No.1 to the Mitigated Negative Declaration. The Addendum addressed the changes in the configuration of the C&D sorting equipment and the relocation of the facility operations to the east side of the property. In March 2016, the LEA prepared Addendum No.2 to address the requested revision to the SWFP to combine the C&D processing facility and the Type A Inert operation into a single permit and to allow for minor alterations in the configuration of the site operations.


4. Finding of Conformance

The California Waste Services facility is listed in the City of Los Angeles Nondisposal Facility Element (NDFE) in Table 1.18.

As required by 14 CCR 21570, the LEA is submitting a copy of the accepted application form and a copy of the TPR as an attachment to this determination letter.
