Description of Project and LEA's Determination

The North Hills Recycling, Inc. Chipping and Grinding Facility is an approximately 0.39-acre medium volume chipping and grinding facility located at 11700 Blucher Ave., in Granada Hills (Los Angeles), California.

On January 2, 2024 the LEA received from North Hills Recycling, Inc an application for a Registration Permit for a medium volume chipping and grinding facility with a limit of 499 tons per day (tpd) green waste and wood. The application package contained a completed registration permit application form, a facility plan, and a notification letter to City Planning. No meetings were required for this project.

The LEA found that the application package meets the filing requirements pursuant to Section 18104.1 of Title 14 of the California Code of Regulations. The registration permit is a non-discretionary permit and does not require the applicant to submit evidence of CEQA compliance. Therefore, the LEA has issued a Registration Permit on January 3, 2024 to North Hills Recycling, Inc. to operate a medium volume chipping and grinding operation.
