#### **Description of Project and LEA's Determination**

The American Reclamation CDI Processing Facility is a medium volume CDI debris Processing Facility that is approximately 0.3 acres in size within the property of the Glendale Metals Material Recovery Facility and is permitted to accept up to 175 tons/day of construction debris and inert debris. The facility is located at 4560 Doran Street, Los Angeles, California.

On September 12, 2024, the LEA received an application package from American Reclamation for a new Registration Permit to increase the permitted area of the facility from 0.3 acres to 1.38 acres without increasing the tonnage. The LEA reviewed the application and on September 12, 2024, the LEA determined that the application was complete and correct and issued a new Registration Permit.
